2:45 p.m. – 3:45 p.m. The Motor Carrier Exemption to the Fair Labor Standards Act

The Fair Labor Standards Act (FLSA) generally requires employers to pay overtime to non-exempt workers. The Motor Carrier Act exemption (MCE) to the FLSA provides that certain drivers, loaders, and mechanics are not entitled to overtime pay. In general, in order to qualify for this exemption, an employee must be (1) employed by a motor carrier or private motor carrier, (2) engaged in activities affecting the safe operation of motor vehicles on public highways in transportation in interstate commerce, and (3) not covered by the small vehicle exception. In this session speakers will discuss these requirements and circumstances where certain intrastate drivers can qualify for this exemption.
